YOUR PRIVACY MATTERS

Thank you for visiting www.latamemifund.com, which is owned and operated by Latam EMI Fund SPC Ltd, ("Latam EMI Fund"). By using or accessing the Site in any way, you acknowledge that you accept the practices and policies outlined in this Privacy Policy, and you hereby consent to our collection, use and sharing of your information in the manner described herein. "LATAM EMI FUND" is committed to respecting and protecting your privacy. Please read this Privacy Policy carefully in order to understand what information "LATAM EMI FUND" collects about visitors to the Site, and how "LATAM EMI FUND" uses that information. If you do not agree with the content of this Privacy Policy, please do not use this Site. TYPES OF INFORMATION COLLECTED BY "LATAM EMI FUND"

"LATAM EMI FUND" collects two types of information from visitors to the Site, non-personal information and personal information. Non-personal information is information that does not, by itself, identify the visitor as a specific individual. Personal information, is information that specifically identifies a visitor to the Site, or which includes contact information. If you sign up to receive "LATAM EMI FUND" news, provide contact information or other information about yourself when signing up for a "LATAM EMI FUND" event, or express interest in the "LATAM EMI FUND" projects, "LATAM EMI FUND" may request and you may be required to provide personal information, including, without limitation, your e-mail address. By providing "LATAM EMI FUND" with personal information via the Site, you expressly agree to its collection and use as described in this Privacy Policy. If you do not want to receive communications from us, please indicate your preference by clicking on the "Unsubscribe" link at the bottom of an email message.

COLLECTION OF INFORMATION

Visitors may access the Site while remaining anonymous and without revealing any personal information. "LATAM EMI FUND" may collect information during your visit to the Site through our automatic data collection tools, which may include cookies and other commonly used information gathering tools. These tools collect certain standard information that your browser sends to our website such as your browser type and language, access times, and the address of the website from which you arrived at a "LATAM EMI FUND" website. They may also collect information about your Internet Protocol (IP) address and clickstream behavior (i.e. the pages

you view, the links you click, and other actions you take in connection with “LATAM EMI FUND” websites). A "cookie" is a small piece of data stored on a user's browser, and contains non-personally identifiable information about the user. CHILDREN'S PRIVACY

“LATAM EMI FUND” is committed to protecting the privacy of young children, and therefore does not knowingly collect or maintain personally identifiable information on the Site from persons under 13 years of age, and no part of our website is directed to persons under the age of 13. IF YOU ARE UNDER 13 YEARS OF AGE, THEN PLEASE DO NOT USE OR ACCESS THE SITE AT ANY TIME OR IN ANY MANNER. HOW “LATAM EMI FUND” USES AND SHARES INFORMATION

“LATAM EMI FUND” may use personal information you provide in order to contact you.
